

The 125-percent rule in electrical code means your main service panel cannot be loaded beyond 125 percent of its rated amperage under continuous operation, a safety ceiling that demands immediate professional attention when breached. When continuous load exceeds that limit, the wiring inside your panel begins to degrade, connections loosen, and heat builds. A breaker that should hold firm begins to fail. An electrician arriving the same day you call can disconnect the overload before serious damage occurs—before insulation melts, before sparks ignite nearby materials, before a fire spreads to your attic or walls. Your heating system in winter, your central AC in summer, your electric water heater—these are continuous loads. Add them together, multiply by 1.25, and that total cannot exceed your panel's rated amperage. If it does, you are in violation and at risk. An emergency electrician evaluates this calculation during the dispatch call to prioritize your case. If your panel is 200 amps and your continuous loads exceed 160 amps (200×1.25), you are over the threshold. Our
