

Large trees change a property in ways smaller plantings never can. They cast meaningful shade, shape the look of a street, soften wind, and give a home or commercial site a sense of permanence. They also carry weight, literally and financially. When a mature tree develops structural defects, overextends toward a roofline, loses limbs in a storm, or begins declining near a driveway or play area, the decision is rarely simple.
