

Palm Beach Gardens has a way of looking polished without feeling sealed off from the rest of South Florida. The city sits in that rare middle ground where you can still read the landscape, the roads, the older commercial corridors, the neighborhoods built around canals and preserved green space, and the newer districts that arrived as the population kept moving north through Palm Beach County. It is a place shaped by planned growth, but not in a sterile sense.
