

If a dog bit you in the Atlanta area, the legal standard surprises most people.

In some places an owner is liable automatically. Georgia is not one of them. The claim generally turns [atlanta personal injury attorney](#) on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether anyone contacted animal control.

These records fade fast. County records and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
