

If you were hurt by electrical contact in Georgia, the answer is rarely a single company.

There is the property owner, the general contractor, the electrical sub, sometimes the utility, sometimes an equipment manufacturer, and sometimes a staffing agency. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
