

When someone is shocked or burned on a job site around Atlanta, several companies may share responsibility.

There is the property owner, the general contractor, the electrical subcontractor, sometimes the utility, occasionally an equipment maker, and sometimes a staffing agency. Each has [truck accident lawyer](#) different insurance and different incentives to point at the others.

Workers ***experienced car accident lawyer*** compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.

Electrical burns are systematically undervalued early. Scarring that requires staged revision show up over months, long after the initial bill is written. Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
