If the app is off, it is an ordinary car wreck, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a much larger commercial policy typically comes into play.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each one can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
