

Losing someone in a preventable crash is not a legal problem first. It becomes one [truck accident lawyer](#) eventually, often when the bills arrive or an adjuster calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. Georgia law sets an order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a commercial vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
