

If you were hurt on a bus [truck accident lawyer](#) in Atlanta, the deadline may be far shorter than you think.

Missing that notice can end an otherwise strong case before it starts.

Who owns the bus drives the analysis. A public bus, a school bus and a private charter are three different cases. It sets the deadline, the immunity questions and what insurance responds.

Video is the other clock. Transit and charter buses carry multiple cameras, and footage is frequently overwritten within weeks. A preservation letter sent late is a letter about footage that no longer exists.
