Parties

This MEDIATION AGREEMENT (hereafter known as "Agreement"), dated July 26, 2021, is made between **Matt E. Rikard**, a resident of 1148 Brown Street, Vian, Oklahoma 74962 ("Mediator"), and **Tim D. Recitals
