

If a dog bit you in the Atlanta area, Georgia works differently than people expect.

Some states hold the owner responsible no matter what. That is not the Georgia rule. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether a [truck accident lawyer](#) leash law was being broken at the time.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

These records fade fast. Prior complaints and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
