

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer depends on what the driver was doing at that exact moment.

If the app is off, it is an ordinary car wreck, and only the personal policy is [https://articlegrovey.com/s/WqxxglsnCJ88b\\_OLJc0G1g](https://articlegrovey.com/s/WqxxglsnCJ88b_OLJc0G1g) in play. When the app is on and they are waiting for a ride request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each position can reach a different layer of coverage.

## **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. ## **How long do I have to file an injury claim in Georgia?**

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. ## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
