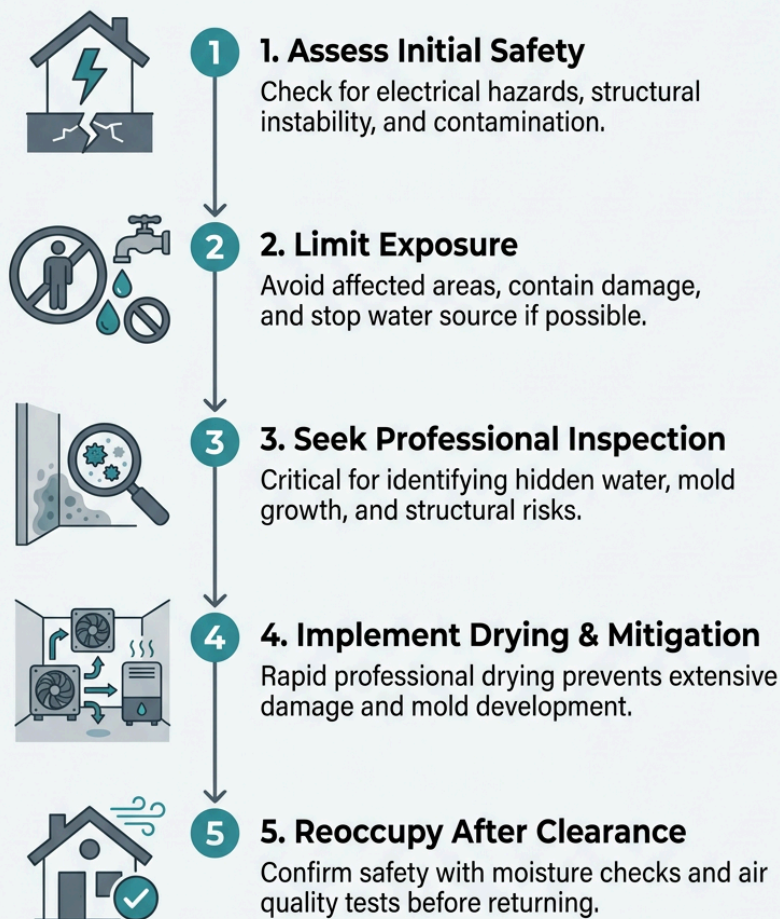

How Does Moisture Verification Documentation Separate Salvageable From Unsalvageable Drywall?

The distinction between "dried out" and "salvageable" is not made by sight or touch—it is made by calibrated measurement and documented comparison.
