

If a bus crash injured you in Atlanta, the timeline is not the usual one.

The general Georgia deadline for injury suits is two years. Where a government entity owns the bus, written notice may be due in months rather than years, in a specific form, to a specific office.

Missing that notice can end an otherwise strong case before it starts.
