

If you were hurt by electrical contact in Atlanta, the answer is rarely a single company.

There is the property owner, a general contractor, the electrical subcontractor, sometimes a utility, occasionally an equipment maker, and sometimes a staffing agency. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the **truck accident lawyer** hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
