

If you ride and a driver did not see you in Georgia, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: that the rider was going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Occasionally that is true. Usually the car turned left across a rider who [truck accident lawyer](#) had the right of way.

These cases get built on physical evidence rather than narrative, because narrative starts at a disadvantage. The geometry of the turn carry more weight than either version of events.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
