

How the Anion Gap Is Measured

The **anion gap** is a derived value that assists interpret an electrolyte panel and recognize certain **acid-base disorder** patterns. It compares the main positively charged and negatively charged particles in **serum electrolytes**, especially **sodium**, **chloride**, and **bicarbonate**. Because routine chemistry tests do not measure every charged particle in the blood, the anion gap estimates the difference between measured cations and measured anions.

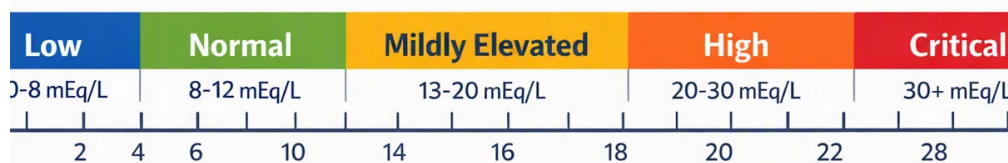
