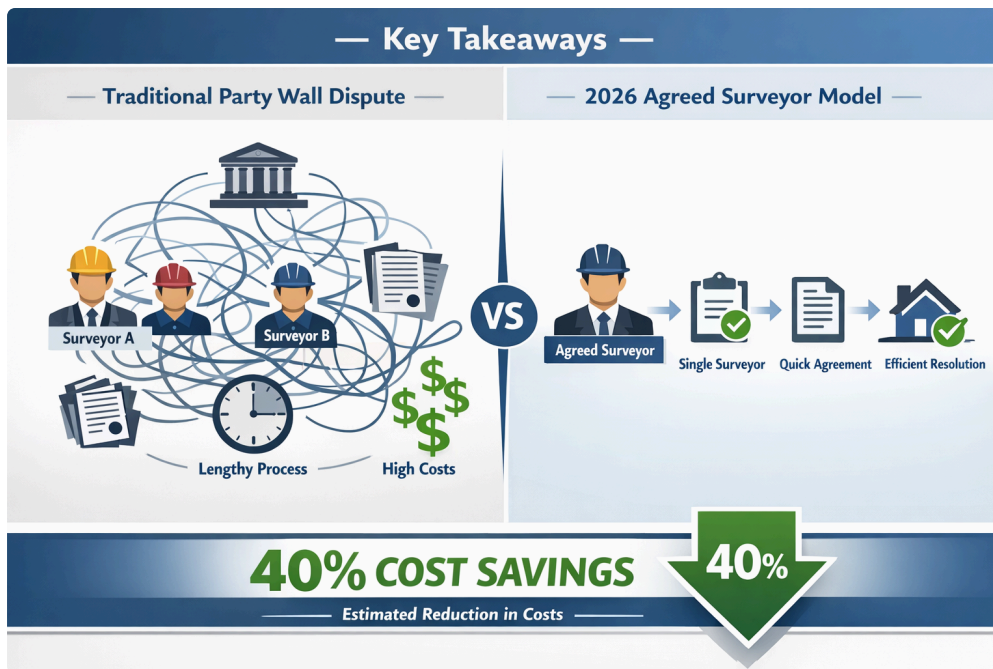

For how long does an event wall notification last?

Party Wall Awards are binding unless appealed within 14 days. No legal expiry exists, but land surveyors usually consist of a 12-month legitimacy condition. Section 3 and 6 notifications end after 12 months. Financial enforcement is generally time-barred after 6 years.

Differences can surface when neighbors do not agree on building plans near party wall surfaces or they have valid problems. The Celebration Wall surface Act 1996 needs a notification period to be offered to neighbours.
