

If a bus crash injured you in Georgia, the timeline is not the usual one.

The general Georgia deadline for injury suits is two years. Where a government entity owns the bus, written notice may be due in months rather than years, in a specific form, to a specific office.

Missing that notice can end an otherwise strong case before it starts.

Ownership determines almost everything here. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. Ownership sets the notice requirement, the immunity analysis and what insurance responds.

Video is the other clock. Transit and charter buses carry multiple cameras, and footage is frequently overwritten within weeks. Ask too late and there is nothing left to preserve.
