

If a bus crash injured you around Atlanta, there is a clock most people never hear about.

An ordinary Georgia injury claim generally allows two years to file. Where a government entity owns the bus, written notice may be due in months rather than years, and it has to be in the right form and go to the right place.

A late notice can close a good claim before anyone looks at the merits.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
