Step 1 — Clarify outcomes and success metrics

Step 2 — Inventory data inputs and readiness

- Details: Use a representative subset of lanes to compare automated findings with manual results. Iterate on rules and thresholds based on feedback.

Step 6 — Scale, govern, and sustain

- Direct answer: Expand coverage and embed governance for long-term value.
- Details: Add more lanes, monitor performance, and update contracts as needed. Use analytics to guide negotiations and process improvements.
