

A truck wreck is not a car wreck. A fully loaded truck can outweigh your car many times over, and people tend to get hurt much worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene the same day, before you are out of the hospital. They start protecting the company immediately.

More than one company can be responsible. The trucking company, a maintenance contractor, a freight broker, or whoever loaded the trailer can each share it. Each of those is its own question with its own evidence.

Commercial trucks also create records an ordinary car never does: electronic logging records, engine data, maintenance history, and the file the carrier keeps on the driver. Much of it can be overwritten or discarded on a normal schedule, so a preservation demand is typically sent right away.
