

Riding in an Uber feels routine until a crash snaps everything into slow motion. If you were a passenger in Georgia, you likely assumed someone's insurer would simply step up. The reality is more technical. Your rights depend on a tangle of deadlines, insurance layers, and a few Georgia-specific rules that can quietly extend or destroy a claim. Miss a cutoff by a day, and even a strong case can evaporate.

I have spent years walking clients through these timelines, including Uber, Lyft, taxi, and bus crashes. The patterns are familiar: people feel fine at the scene, then pain flares 48 hours later. An adjuster sounds friendly, then goes silent after you mention an MRI. Meanwhile, the calendar keeps moving. This guide unpacks the statute of limitations for Uber passengers in Georgia and the practical checkpoints that keep cases on track.

## **Why timing feels confusing for Uber passengers**

As a passenger, you did not cause the collision. Georgia's modified comparative negligence rule does not reduce your recovery for someone else's fault when you were just along for the ride. Yet the statute of limitations, service rules, and insurance notice requirements still apply to you. Rideshare claims add layers:

- Two different drivers, each possibly at fault.
- Uber's \$1 million policy may apply, but only in certain app-on stages.
- Your own uninsured motorist coverage might be triggered, often with strict notice rules.
- If a criminal case is pending against a driver, Georgia may pause the civil clock.
- If a government vehicle was involved, special ante litem notices come first.

None of this is obvious from the crash scene or the Uber app receipt.

## **The core rule: two years for injury claims in Georgia**

For most Uber passenger injury claims in Georgia, the statute of limitations is two years from the date of the auto accident. This is the general rule for personal injury under Georgia law. If you file a lawsuit after two years, a court will likely dismiss it. Settlement talks do not stop the clock. Verbal promises from adjusters do not stop it either.

A few anchor points help:

- Injury to a person: typically 2 years.
- Property damage: up to 4 years.
- Wrongful death: generally 2 years from the date of death, which can be the crash date or a later date if death occurs afterward.
- A survival claim for the estate, such as the decedent's conscious pain and suffering before death, usually shares the 2-year period.

Most riders only need the first point. But if a loved one passed away after an Uber crash, both wrongful death and estate claims must be tracked. They are related but not identical.

## **Special Georgia rules that can pause or extend the deadline**

Georgia recognizes several circumstances that can toll, or pause, the statute of limitations. These are not blanket extensions, and they come with limits. The three I see most in rideshare cases are below.

Criminal prosecution tolling. If a traffic offense or crime arising from the crash is being prosecuted, Georgia law can toll the civil statute of limitations for the duration of the prosecution, up to six years. Think DUI, hit and run, or serious injury by vehicle. This rule can save a claim that might otherwise expire while the district attorney pursues a criminal case. You still need to monitor the docket. Once the criminal case ends, the civil clock restarts with whatever time remained.

Minors and legally incompetent persons. For minors injured as Uber passengers, the two-year period generally does not start until the child turns 18, although certain claims for medical bills belong to the parents and follow normal deadlines. For adults deemed legally incompetent, the period can be tolled during the disability. These situations can be complicated, and guardians often need court approval for settlements.

Unknown or fleeing drivers. Hit-and-run scenarios are painful for passengers because the driver who caused the wreck might vanish. Georgia allows "John Doe" lawsuits to preserve claims while you pursue uninsured motorist benefits, but only if you use due diligence to identify the driver and follow strict UM notice rules. Some UM policies require notice within 30 days of a hit-and-run. Miss that, and a strong claim can die on a technicality, even if you file the lawsuit within two years.

Other tolling situations exist, such as when a defendant is out of state, but they are less common in Uber passenger cases. The point is simple: do not assume the two-year date is final without asking whether a tolling rule helps or hurts you. It cuts both ways.

## **When a government vehicle is involved**

Every so often, an Uber gets hit by a city bus, a county maintenance truck, or a state patrol vehicle responding to a call. Claims against government entities have strict ante litem notice requirements that come long before a lawsuit. For a city in Georgia, notice typically must be given within six months. For a county, within twelve months. These notices must follow exact content rules and be delivered to the correct officials. If you miss the ante litem window, your claim may be barred even if you still have time left under the two-year statute.

I have seen strong injury cases fail because someone sent a friendly letter to a department head instead of a compliant ante litem notice to the correct legal officer. If there is even a hint that a public vehicle was involved, verify immediately and handle the notice precisely.

## **What insurance applies when you are an Uber passenger**

The stage of the Uber ride decides which coverage applies:

- App on, passenger accepted, or passenger in the vehicle: Uber provides at least \$1 million in liability coverage for bodily injury per crash. Georgia also requires uninsured or underinsured motorist coverage in this stage, typically up to \$1 million, though forms and endorsements vary.
- App on, no passenger accepted: lower contingent liability limits apply for the driver.
- App off: the driver's personal auto policy is primary.

As a passenger, if another driver is at fault, that driver's liability insurance is primary. If that insurance is insufficient, Uber's UM coverage may supplement. If your Uber driver caused the crash, Uber's \$1 million liability policy usually comes into play during an active trip. If the at-fault driver is uninsured or flees, Uber's UM coverage often steps up.

Georgia is an at-fault state. There is no required personal injury protection. Some passengers carry optional medical payments coverage on their own policy that can help with immediate bills regardless of fault. MedPay in

Georgia generally follows the insured and can apply even when you were a passenger in a rideshare, subject to policy terms.

## Which deadline applies to which claim

Different clocks can govern different avenues of recovery. It helps to sort them by legal theory rather than by insurer logo.

Tort claims against at-fault drivers. This is the standard negligence claim for bodily injury and pain and suffering. The two-year statute of limitations applies. If you are hurt as an Uber passenger, you usually file against the negligent driver or drivers, not necessarily against Uber as a first move. Uber's insurer may still fund the settlement if its driver is at fault during a covered trip, but your claim remains a tort claim.

Uninsured and underinsured motorist claims. In Georgia, UM benefits are often pursued within the same tort case. You still need to file the tort lawsuit within two years and then serve your UM carrier according to policy terms. If the at-fault driver is unknown, a John Doe action preserves the right to UM benefits, but notice deadlines inside your policy can be much shorter than two years. Contract claims against your UM carrier, such as for failure to pay benefits, can involve a longer six-year contract statute, but you cannot ignore the two-year tort limit that anchors the underlying case.

Property damage. If you, not the Uber driver, had property losses, such as a damaged laptop or camera equipment, Georgia allows up to four years to bring a property damage claim. In practice, property issues are resolved early.

Wrongful death and estate claims. Families often face two tracks: a wrongful death claim brought by statutory survivors and an estate claim for the decedent's pain, suffering, and medical bills. Both commonly follow the two-year limit, but tolling for a pending criminal prosecution or the time required to open an estate can affect the calendar. Coordinate the filings to avoid a mismatch that undercuts leverage.

Bad faith against insurers. Georgia allows extra-contractual penalties for an insurer's bad faith refusal to pay certain claims, though the prerequisites and deadlines are different from the underlying injury claim. Do not confuse the bad faith clock with the statute of limitations for the injury itself.

If your case crosses categories, sequence matters. For example, failing to file the tort suit in time can also gut your UM claim, even if you think you have a longer contract window. I have had to fix more than one situation where a self-represented passenger settled property damage, then waited on medical treatment, only to realize the injury claim deadline had passed.

## Arbitration and Uber's terms of service

Many riders consent to Uber's terms on signup, which typically include an arbitration clause. Arbitration is not a bar to your claim, but it can change the forum and procedure. Statutes of limitation still apply. Some arbitration administrators require filing fees and a formal demand that mirrors a lawsuit. I have handled Uber arbitration demands where filing early opened access to data the claims team would not otherwise share, such as precise trip telemetry. ## Evidence that makes or breaks an Uber passenger case

Time kills evidence. App data helps, but it is not a substitute for early groundwork. I ask clients to move on four fronts within days, not weeks, of the crash:

- Preserve the Uber trip data: screenshots of the receipt, route map, driver identity, and timestamps. Back them up. The app can update or purge old data.
- Seek medical evaluation quickly: delayed care invites arguments that you were not hurt or that something else caused your symptoms.
- Identify all vehicles and drivers: photograph license plates, insurance cards, and any Uber trade dress on the windshield. If police did not respond, file a report within 24 hours when feasible.
- Track witnesses: names, phone numbers, and short summaries of what they saw. Do not trust that the app or officers captured everyone.
- Send preservation letters: when injuries are significant, spoliation letters to Uber and any commercial defendants can help secure dashcam footage, telematics, and driver logs.

These steps take pressure off the statute of limitations because strong evidence gives you options. Weak evidence forces last-minute filings.

## **How comparative fault interacts with a passenger's claim**

Georgia uses a modified comparative negligence rule with a 50 percent bar. It rarely reduces a passenger's case because passengers generally are not at fault. Still, insurers sometimes try sideways arguments: you were not wearing a seatbelt, you distracted the driver, you chose to ride with a visibly intoxicated driver. Most of these are weak in practice, but they appear in negotiations. The cleaner your facts and documentation, the less oxygen those defenses get.

## **Two quick timeline examples**

A weekend DUI collision. You are in an Uber on a Saturday night. A drunk driver runs a red light and T-bones the car. The driver is arrested at the scene and later prosecuted for DUI. In this scenario, your two-year civil deadline may be tolled during the criminal case, up to six years. If the prosecution takes 14 months, that period usually does not count against your civil filing window. Still, you should not wait. File once you understand your medical picture and have the necessary records.

A hit-and-run on I-85. Your Uber is sideswiped at highway speed. The at-fault driver flees. Police never find a plate. You must treat this as a UM claim from day one. Notify your own UM carrier immediately, and notify Uber's insurer during the trip phase that applied. Your policy might require written notice within 30 days. If you file a John Doe lawsuit, do it within two years and be prepared to show diligence in trying to identify the driver. This is one of the most deadline-sensitive setups I see.

## **Key Georgia deadlines at a glance**

- Personal injury from a car crash: usually 2 years from the date of the accident.
- Property damage: up to 4 years.
- Wrongful death and estate survival claims: generally 2 years, subject to tolling rules.
- Government ante litem notices: often 6 months for cities, 12 months for counties.
- Criminal case tolling: the civil clock can pause during prosecution, up to 6 years.

These are general guideposts. Individual policies, arbitration agreements, and hit-and-run UM terms can impose shorter notice requirements.

## **What happens if you miss the statute**

If you miss a statute of limitations, courts almost always dismiss the case. Insurers know this and will stop negotiating once they realize you are out of time. There are narrow exceptions based on specific tolling rules, but you should not count on them. I have watched strong claims with clear liability and significant medical treatment lose all settlement value because the filing happened a week late. No lawyer enjoys delivering that news.

## **Damages a passenger can recover**

A good Auto Accident Lawyer will pull the full damages picture into focus. For Uber passengers, typical categories include medical expenses, lost wages or lost earning capacity, pain and suffering, and functional losses that quietly reshape daily life. Georgia allows recovery for future medical needs when supported by medical opinion and cost data. Insurers often minimize non-economic harm, but certain injuries common in rideshare crashes, such as cervical disc herniations or post-concussive syndrome, leave long shadows. The strength of your proof matters more than the length of your treatment.

If a family is pursuing a wrongful death claim, Georgia measures that loss by the full value of the decedent's life from the perspective of the decedent. That includes both economic and intangible components. Estate claims cover medical bills and conscious pain and suffering between injury and death. Sorting these categories early helps align the evidence and expert workup.

## **Practical negotiation rhythm with rideshare insurers**

With \$1 million limits in play during an active trip, Uber claims teams watch medical records closely. They will ask for prior records and scrutinize gaps in care. I have found that presenting a clean, chronological medical package plus a short liability summary works best. Keep the tone factual and avoid hyperbole. Reference the app status clearly. If UM coverage is likely, serve the UM carrier under the policy and include them in key updates. Preserve your leverage by filing suit before the two-year mark if negotiations stall.

If a commercial defendant is involved, like a freight company in a multi-vehicle pileup, expect a longer discovery phase. A Truck Accident Lawyer would approach that differently than a straightforward Car Accident claim, with emphasis on driver logs, telematics, and fleet safety policies. Passengers should not assume that complexity extends the statute. It does not.

## **How a lawyer strengthens a passenger's timeline**

A seasoned Car Accident Attorney starts with a calendar and a map: who might be at fault, which policies apply, and what deadlines control each path. They confirm app status, demand trip data, and request the crash report, bodycam footage, and any available dashcam video. If there is a hint of a pending DUI or reckless driving charge, they track the criminal docket and compute tolling conservatively. If a city or county vehicle is in the chain, they draft ante litem notices with all statutory elements and deliver them to the correct recipients.

I also press early on lien issues. Hospital liens, health insurer subrogation claims, and Medicare interests can complicate settlement timing. Cleaning those up in parallel keeps the two-year deadline from colliding with last-minute lien fights.

From a client's side, the most valuable action is consistent medical care and communication. Tell your lawyer when you start or finish a treatment phase, when new symptoms appear, or when work restrictions change. Good documentation is the antidote to delay tactics.

## **Frequently asked edge cases**

What if the Uber driver and the other driver both blame each other? File against both within two years and let discovery sort fault. Georgia allows you to pursue multiple defendants and collect from the one, or combination, ultimately responsible.

What if I did not call the police? You can still pursue a claim. File a report promptly, gather what evidence you can, and document your medical treatment. Lack of a police report is a hurdle, not a wall.

What if my injuries seemed minor at first? Many legitimate Uber passenger claims start with soft tissue complaints and evolve as imaging reveals structural injuries. The two-year window anticipates this. The key is to seek evaluation early and follow medical advice so that your records reflect the progression.

What if my phone died and I lost the trip details? Uber's support can help retrieve records, and your lawyer can subpoena additional data if a lawsuit becomes necessary. Still, take screenshots of trip details as a habit. It saves time later.

## **Final takeaways for Georgia Uber passengers**

For most injured passengers, the two-year statute of limitations controls. That anchor date does not care whether an adjuster has been kind, an offer sounds likely, or you are still treating. Georgia's tolling rules can help in specific circumstances, especially when a criminal prosecution is pending, but counting on an exception is risky. Layer on potential 30-day or similar notice requirements for uninsured motorist claims in hit-and-run cases, and you have the outline of a plan: get medical care, secure the trip data, identify all potential defendants, give timely notice to every applicable insurer, and file suit before the clock runs out if settlement has not landed.

A careful Car Accident Lawyer can integrate those pieces, whether the case is a straightforward rear-end crash or a multi-vehicle pileup involving issues more familiar to a Truck Accident Attorney or Bus Accident Lawyer. The work is procedural, not glamorous, but it preserves what matters: the chance to be made whole.
